  - Promoting membership through publication, conferences, and social media
  - Worked with IRA to get their membership information in our publications
  - 2,096 current members. Will likely increase at conference time.

- - Publications: working with committee to update and revise publications. The committee is revising early literacy document to make it user-friendly for parents, as well as provide in various languages.
  - Kaleidoscope: there are currently 96 submissions
  - Region 6: Washtenaw council dissolved, but Sean is working with a Washtenaw literacy coalition to see if we can partner.
  - Office Personnel: completing evaluations
  - Historian: working on archives
  - Region 8: Tamara met a slam poetry group that she would like to
  - News and Views: will be going to print soon.
  - Awards: Announced winners of literacy awards. Thanked the board for their nominations for the Gwen Frostic award.
  - Member-at-large C. Harris: She and B. Nelson will be presenting at CLASS in April.
  - Member-at-large S. Piazza: MARP will be meeting during the conference.
  - Great Lakes/Great Books: everything is in for the year. Committee met last week on the new ballot for next year. Lynette will have a session at the conference, and there will be an exhibit. The committee received an award from MAME (Michigan Association for Media Education) for promoting reading
  - Public Relations: working on getting the word out on the annual conference and the summer conference. Considering ways to promote the conference on opposite sides of the state.
  - M. Klemp encouraged board members to attend the Past Presidents' dinner.
  - Office Update: Registration is going much more smoothly than previous year. System is set up so that registrants know if they owe money, which will alleviate issues at the conference. Nothing will be mailed out before the conference. The office has hired a temporary support person to assist with the conference. Deposit was sent in for 2016 conference at Cobo Hall. There are about 100 exhibitors for 2014, and a number of sponsorships. Laura continues to find ways to promote our organization with others. Working on a new connection with Michigan Library Association. E.L.L flip-charts are very popular; had to order more.

  - Trying to figure out how this might work financially, etc.
  - Will continue the discussion, and have plans to move forward
- D. MARP as a new council S. Piazza
  - Michigan Association of Reading Professionals is proposing to the board to become a Special –Interest Council
  - Will formally propose when IRA lifts the hold on new councils
  - L. Rose stated that a similar council existed many years ago, and that it would be nice to have a group like this again.
- E. Diversity Committee

- Committee will be meeting at the annual conference
- Trying to come up with ideas to provide support and increase participation from underserved areas
- - Spoke with other conference leaders from other organizations
  - MACUL charges \$50 for presenters
  - Need to consider as a board if we want to provide a reduced fee for future conference presenters.
  - L. Guzman: one sponsor provided all presenters with a 1-year membership to Lesson Planet
  - T. Campbell: suggested renewing their membership at no cost.
  - E. Nelson: many schools are not supporting conference attendance.
  - L. Madden: requested that office provide an approximate number of presenters and what the financial impact may be with a reduced or waived fee.
  - L. Suckow: suggested a half-price registration.
  - E. Nelson: asked that we look at what the cost would be with the various scenarios.
  - T. Campbell: could invite them to a special celebration
  - L. Guzman: will bring more information to the next meeting
- G. Pinterest Board......B. Nelson
  - Pinterest is becoming one of the most popular social networking sites.
  - Currently underutilized by MRA.
  - Suggested having boards with different topics relative to literacy instead of listing individual boards.
  - Could look at the conference strands to create the various categories.
  - This could potentially increase involvement.
  - C. Sharp: commented that we are also underutilizing twitter, as well.
  - D. Halstead: connect Jessie about access to the @michiganreading account.
  - Use #MRA14 in tweets.
  - T. Campbell: need to provide "how-to" sessions.
